## GDPR information clause

According to Article 13 of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons in connection with the processing of personal data and on the free movement of such data and repealing the Directive 95/46 / EC (hereinafter: GDPR) we inform that:

The data is collected for the purposes of the current recruitment process or future identical recruitments (maximum for a period of 1 year), the basis for processing is your consent voluntarily and knowingly in connection with art. 6 clause 1 lit. and GDPR.

In accordance with applicable law, personal data may be transferred to processors (**Article 28 (1) of the GDPR**) as well as made available to bodies authorized pursuant to legal provisions. At present, service providers, who provide recruitment services for us, do not cooperate with us.

The data will be stored only for a period of 1 year or until you withdraw your previously granted consent, at its withdrawal will not affect earlier processing. You have the right to access your data, their right rectification, the right to transfer data, to delete it or limit processing, and the right to object to processing. You have the right to lodge a complaint with the President of the Office for Personal Data Protection if you feel that the processing of your personal data violates the provisions of the General Regulation on the Protection of Personal Data of April 27, 2016. Providing personal data by you is voluntary. Unfortunately, the consequence of not providing personal data will be lack the possibility of considering your candidacy for a vacant job. Your data will not be processed in an automated manner, including in the form of profiling.
